"A RESOLUTION ADOPTING AND AFFIRMING THE 20% LOCAL DEVELOPMENT FUND (20% LDF) BUDGET FOR FISCAL YEAR 2023 OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE TOTAL AMOUNT OF THIRTEEN MILLION NINE HUNDRED FIFTY THOUSAND NINE HUNDRED SEVENTY-SIX PESOS (P 13,950, 976.00) "

WHEREAS, submitted for review of this honorable body the 20% Local Development Fund (20% LDF) Budget for Fiscal Year 2023 of the Municipality of San Benito, Siargao Island, Surigao del Norte in the amount of THIRTEEN MILLION NINE HUNDRED FIFTY THOUSAND NINE HUNDRED SEVENTY-SIX PESOS (P 13,950, 976.00);

WHEREAS, upon scrutiny and study of this august body it appears that said 20% LDF Budget for FY 2023 is within the budgetary limit of this Municipal Government and such programs, projects and activities containing thereat are consistent and in accord with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991 and the Joint Memorandum Circular No. 2017 - 1, dated February 22, 2017 of DILG and DBM;

WHEREAS, such 20% LDF projects, programs and activities for FY 2023 are all in line with the present administration's thrust and priorities and these infrastructure projects are believed to be of great help in accelerating economic development and alleviating poverty incidence in the municipality;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Jayrom P. Caballejos, be it;
