“A RESOLUTION ADOPTING AND AFFIRMING THE 20% LOCAL DEVELOPMENT FUND (20% LDF) BUDGET FOR FISCAL YEAR 2023 OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN THE TOTAL AMOUNT OF THIRTEEN MILLION NINE HUNDRED FIFTY THOUSAND NINE HUNDRED SEVENTY-SIX PESOS (P 13,950, 976.00) “

WHEREAS, submitted for review of this honorable body the 20% Local Development Fund (20% LDF) Budget for Fiscal Year 2023 of the Municipality of San Benito, Siargao Island, Surigao del Norte in the amount of **THIRTEEN MILLION NINE HUNDRED FIFTY THOUSAND NINE HUNDRED SEVENTY-SIX PESOS (P 13,950, 976.00)**;




