“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO – MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO WITH THE DEPARTMENT OF EDUCATION – SIARGAO DIVISION IN RELATION TO THE IMPLEMENTATION OF PRE-EMPTIVE AND FORCE EVACUATION BEFORE, DURING AND AFTER THE OCCURRENCE OF CALAMITIES AND DISASTERS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE IN PURSUANCE TO REPUBLIC ACT NO. 10121, ALSO KNOWN AS PHILIPPINE DISASTER RISK REDUCTION AND MANAGEMENT (PDRRM) ACT OF 2010”

WHEREAS, the foremost goal of Republic Act No. 10121, also known as Philippine Disaster Risk Reduction and Management (PDRRM) Act of 2010 is to strengthen the country's National DRRM System towards sustainable economic development, by mainstreaming the same in all national and local development processes;

WHEREAS, as enshrined in the above quoted Republic Act, the LGU through its LDRRMC shall execute a pre-emptive and force evacuation to all residents living in hazard prone areas before and during the occurrence to ensure that all residents living in those areas are being

secured and evacuated to safe places to the sdesignated evacuation centers, such as schools, churches and local evacuation centers;

WHEREAS, school buildings and sites are utilized as the immediate evacuation area of the community everytime there is a pre-emptive and force evacuation due to calamities, thus there is a need to formalize this partnership between the LGU- San Benito and DepED – Division of Siargao by entering into a Memorandum of Agreement (MOA), where both parties agree of whatever duties and responsibilities each agency would take charge during and after evacuation period;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Puyat P. Sumando, be it;


RESOLVED AS IT IS HEREBY RESOLVED to authorize the Municipal Mayor, Honorable Ma. Gina Sumando – Menil, LCB to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito with the Department of Education – Siargao Division (DepED-Siargao) in relation to the implementation of Pre-emptive and Force Evacuation before, during and after the occurrence of calamities and disasters within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte in pursuance to Republic Act No. 10121, also known as Philippine Disaster Risk Reduction and Management (PDRRM) Act of 2010;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte) and the Office of the Schools Division Superintendent – Division of Siargao, Dapa, Siargao Island, Surigao del Norte for information and appropriate action;






