RESOLUTION NO. 070

Series of 2021

“A RESOLUTION ADOPTING REPUBLIC ACT NO. 9231, ENTITLED - AN ACT PROVIDING FOR THE ELIMINATION OF THE WORST FORMS OF CHILD LABOR AND AFFORDING STRONGER PROTECTION FOR THE WORKING CHILD, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 7610, AS AMENDED, OTHERWISE KNOWN AS THE “SPECIAL PROTECTION OF CHILDREN AGAINST CHILD ABUSE, EXPLOITATION AND DISCRIMINATION ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Congress of the Philippines enacted R.A. 9231, which was a consolidation of Senate Bill No. 2155 and House Bill No. 4235 was finally passed by the Senate and the House of Representatives on October 14, 2003 and October 13, 2003, respectively and approved on December 19, 2003 into National Law by then President Gloria Macapagal – Arroyo;

WHEREAS, the purpose and intention of this law is primordially for the benefits, protection and welfare of the children, thus this august body hereby adopts the entirety of R.A. 9231 and all its provisions containing thereto are to well implemented and enforceable within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte;

WHEREAS, the Office of the Municipal Mayor through its local offices such as, the Office of the Municipal Social Welfare and Development, Philippine National Police – San Benito Municipal Police Station and all other concerned offices are hereby enjoined to implement this Republic Act within the territorial jurisdiction of this Municipality;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it;

RESOLVED AS IT IS HEREBY RESOLVED to adopt REPUBLIC ACT NO. 9231, ENTITLED - AN ACT PROVIDING FOR THE ELIMINATION OF THE WORST FORMS OF CHILD LABOR AND AFFORDING STRONGER PROTECTION FOR THE WORKING CHILD, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 7610, AS AMENDED, OTHERWISE KNOWN AS THE "SPECIAL PROTECTION OF CHILDREN AGAINST CHILD ABUSE, EXPLOITATION AND DISCRIMINATION ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte, Office of the MSWDO and the PNP – San Benito Municipal Police Station and all concerned offices for information and proper implementation of the above mentioned national law;




