#### **RESOLUTION NO. 071**

Series of 2021

**“A RESOLUTION ADOPTING REPUBLIC ACT NO. 10410, ENTITLED - AN ACT RECOGNIZING THE AGE FROM ZERO (0) TO EIGHT (8) YEARS AS THE FIRST CRUCIAL STAGE OF EDUCATIONAL DEVELOPMENT AND STRENGTHENING THE EARLY CHILDHOOD CARE AND DEVELOPMENT SYSTEM, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, it is the declared policy of the State to promote the rights of children to survival, development and special protection with full recognition of the nature of childhood and as well as the need to provide developmentally appropriate experiences to address their needs; and to support parents in their roles as primary caregivers and as their children's first teachers. Further, the State hereby recognizes the age from zero (0) to eight (8) years as the first crucial stage of educational development of which the age from zero (0) to four (4) years shall be the responsibility of the Early Childhood Care and Development (ECCD) Council. Therefore, the responsibility to help develop children in the formative years between age five (5) to eight (8) years shall be with the Department of Education (DepED);

**WHEREAS**, the purpose and intention of this law is primordially for the benefits, protection and welfare of the children, thus this august body hereby adopts the entirety of R.A.

10410 and all its provisions containing thereto are to well implemented and enforceable within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte;

**WHEREAS**, the Office of the Municipal Mayor through its local offices such as, the Office of the Municipal Social Welfare and Development, Philippine National Police – San Benito Municipal Police Station and all other concerned offices are hereby enjoined to implement this Republic Act within the territorial jurisdiction of this Municipality;

**WHEREFORE**, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Jayrom P. Caballejos duly seconded by LNMB President Ruella T. Rulete, be it;

**RESOLVED AS IT IS HEREBY RESOLVED** to adopt REPUBLIC ACT NO. 10410, ENTITLED - AN ACT RECOGNIZING THE AGE FROM ZERO (0) TO EIGHT (8) YEARS AS THE FIRST CRUCIAL STAGE OF EDUCATIONAL DEVELOPMENT AND STRENGTHENING THE EARLY CHILDHOOD CARE AND DEVELOPMENT SYSTEM, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE;

**RESOLVED FINALLY**, that copy of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte, Office of the MSWDO and the PNP – San Benito Municipal Police Station and all concerned offices for information and proper implementation of the above mentioned national law;


