### **RESOLUTION NO. 073**

Series of 2021

**“A RESOLUTION ADOPTING REPUBLIC ACT NO. 10821, ENTITLED - AN ACT MANDATING THE PROVISION OF EMERGENCY RELIEF AND PROTECTION FOR CHILDREN BEFORE, DURING, AND AFTER DISASTERS AND OTHER EMERGENCY SITUATIONS, OTHERWISE KNOWN AS CHILDREN'S EMERGENCY RELIEF AND PROTECTION ACT of 2016 AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the Congress of the Philippines enacted R.A. 10821, which was a consolidation of Senate Bill No. 3034, which was approved by the Senate on February 1, 2016, was adopted as an amendment to House Bill No. 5285 by the House of Representatives on February 2, 2016 and approved into National Law by then President Benigno C. Aquino III on May 18, 2016;

**WHEREAS**, the purpose and intention of this law is primordially for the benefits, protection and welfare of the children, thus this august body hereby adopts the entirety of R.A. 10821 and all its provisions containing thereto are to well implemented and enforceable within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte;

**WHEREAS**, guided by the principles on survival and development, on child participation, and consistent with the United Nations Convention on the Rights of the Child, as well as the Children's Charter for Disaster Risk and Reduction, and the minimum standards for children in humanitarian action, the State shall establish and implement a comprehensive and strategic

program of action to provide the children and pregnant and lactating mothers affected by disasters and other emergency situations with utmost support and assistance necessary for their immediate recovery and protection against all forms of violence, cruelty, discrimination, neglect, abuse, exploitation and other acts prejudicial to their interest, survival, development and well-being;

**WHEREAS**, the Office of the Municipal Mayor through its local offices such as, the Office of the Municipal Social Welfare and Development, Philippine National Police – San Benito Municipal Police Station and all other concerned offices are hereby enjoined to implement this Republic Act within the territorial jurisdiction of this Municipality;

**WHEREFORE**, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Puyat P. Sumando duly seconded by Sangguniang Bayan Member William A. Polican, be it;

**RESOLVED AS IT IS HEREBY RESOLVED** to adopt REPUBLIC ACT NO. 10821, ENTITLED - AN ACT MANDATING THE PROVISION OF EMERGENCY RELIEF AND PROTECTION FOR CHILDREN BEFORE, DURING, AND AFTER DISASTERS AND OTHER EMERGENCY SITUATIONS, OTHERWISE KNOWN AS CHILDREN'S EMERGENCY RELIEF AND PROTECTION ACT of 2016 AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE;

**RESOLVED FINALLY**, that copy of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte, Office of the MSWDO and the PNP – San Benito Municipal Police Station and all concerned offices for information and proper implementation of the above mentioned national law;
