### **RESOLUTION NO. 074**

Series of 2021

**“A RESOLUTION ADOPTING REPUBLIC ACT NO. 11036, ENTITLED - AN ACT ESTABLISHING A NATIONAL MENTAL HEALTH POLICY FOR THE PURPOSE OF ENHANCING THE DELIVERY OF INTEGRATED MENTAL HEALTH SERVICES, PROMOTING AND PROTECTING THE RIGHTS OF PERSONS UTILIZING PSYCHOSOCIAL HEALTH SERVICES, APPROPRIATING FUNDS THEREFOR AND OTHER PURPOSES, OTHERWISE KNOWN AS MENTAL HEALTH ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the Congress of the Philippines enacted R.A. 11036, which was a consolidation of Senate Bill No. 1354 and House Bill 6452 was finally passed by the Senate and the House of Representatives on February 12, 2018 and approved into National Law by then President Rodrigo Roa Duterte on June 20, 2018;

**WHEREAS**, the purpose and intention of this law is primordially for the benefits, protection and welfare of the children, thus this august body hereby adopts the entirety of R.A. 11036 and all its provisions containing thereto are to well implemented and enforceable within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte;

**WHEREAS**, State commits itself to promoting the well-being of people by ensuring that; mental health is valued, promoted and protected; mental health conditions are treated and prevented; timely, affordable, high quality, and culturally-appropriate mental health case is made available to the public; mental health service are free from coercion and accountable to the service

users; and persons affected by mental health conditions are able to exercise the full range of human rights, and participate fully in society and at work free from stigmatization and discrimination;

**WHEREAS**, the Office of the Municipal Mayor through its local offices such as, the Office of the Municipal Social Welfare and Development, Philippine National Police -- San Benito Municipal Police Station and all other concerned offices are hereby enjoined to implement this Republic Act within the territorial jurisdiction of this Municipality;

**WHEREFORE**, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Jayrom P. Caballejos, be it;

**RESOLVED AS IT IS HEREBY RESOLVED** to adopt REPUBLIC ACT NO. 11036, ENTITLED - AN ACT ESTABLISHING A NATIONAL MENTAL HEALTH POLICY FOR THE PURPOSE OF ENHANCING THE DELIVERY OF INTEGRATED MENTAL HEALTH SERVICES, PROMOTING AND PROTECTING THE RIGHTS OF PERSONS UTILIZING PSYCHOSOCIAL HEALTH SERVICES, APPROPRIATING FUNDS THEREFOR AND OTHER PURPOSES, OTHERWISE KNOWN AS MENTAL HEALTH ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE;
