RESOLUTION NO. 076

Series of 2021

“A RESOLUTION ADOPTING REPUBLIC ACT NO. 11148, ENTITLED - AN ACT SCALING UP THE NATIONAL AND LOCAL HEALTH AND NUTRITION PROGRAMS THROUGH A STRENGTHENED INTEGRATED STRATEGY FOR MATERNAL, NEONATAL, CHILD HEALTH AND NUTRITION IN THE FIRST ONE THOUSAND (1,000) DAYS OF LIFE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES, OTHERWISE KNOWN AS KALUSUGAN AT NUTRISYON NG MAG-NANAY ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Congress of the Philippines enacted R.A. 11148, which was a consolidation of Senate Bill No. 1537 and House Bill No. 5777 was passed by the Senate and the House of Representatives on September 17, 2018 and September 19, 2018 and approved into National Law by then President Rodrigo Roa Duterte on November 29, 2018;

WHEREAS, the purpose and intention of this law is primordially for the benefits, protection and welfare of the children, thus this august body hereby adopts the entirety of R.A. 11148 and all its provisions containing thereto are to well implemented and enforceable within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte;

WHEREAS, the State declares its determination to eliminate hunger and reduce all forms of malnutrition. The State further maintains that ensuring healthy lives, promoting well-being,

ending hunger and food insecurity, and achieving good nutrition for all at all ages are essential to the attainment of sustainable development;

WHEREAS, the Office of the Municipal Mayor through its local offices such as, the Office of the Municipal Social Welfare and Development, Philippine National Police – San Benito Municipal Police Station and all other concerned offices are hereby enjoined to implement this Republic Act within the territorial jurisdiction of this Municipality;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of SKF President Delcy Rose S. Plandano duly seconded by Sangguniang Bayan Member Delfin P. Labola, be it;

RESOLVED AS IT IS HEREBY RESOLVED to adopt REPUBLIC ACT NO. 11148, ENTITLED - AN ACT SCALING UP THE NATIONAL AND LOCAL HEALTH AND NUTRITION PROGRAMS THROUGH A STRENGTHENED INTEGRATED STRATEGY FOR MATERNAL, NEONATAL, CHILD HEALTH AND NUTRITION IN THE FIRST ONE THOUSAND (1,000) DAYS OF LIFE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES, OTHERWISE KNOWN AS KALUSUGAN AT NUTRISYON NG MAG-NANAY ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte, Office of the MSWDO and the PNP – San Benito Municipal Police Station and all concerned offices for information and proper implementation of the above mentioned national law;


