#### **RESOLUTION NO. 077**

Series of 2021

"A RESOLUTION ADOPTING REPUBLIC ACT NO. 11188, ENTITLED - AN ACT PROVIDING FOR THE SPECIAL PROTECTION OF CHILDREN IN SITUATIONS OF ARMED CONFLICT AND PROVIDING PENALTIES FOR VIOLATIONS THERETO, OTHERWISE KNOWN AS SPECIAL PROTECTION OF CHILDREN IN SITUATIONS OF ARMED CONFLICT ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

**WHEREAS,** the Congress of the Philippines enacted R.A. 11188, which was a consolidation of Senate Bill No. 2023 and House Bill No. 7442 was passed by the House of Representatives and the Senate on October 10, 2018 and approved into National Law by then President Rodrigo Roa Duterte on January 10, 2019;

**WHEREAS**, the purpose and intention of this law is primordially for the benefits, protection and welfare of the children, thus this august body hereby adopts the entirety of R.A. 11188 and all its provisions containing thereto are to well implemented and enforceable within the territorial jurisdiction of the Municipality of San Benito, Siargao Island, Surigao del Norte;

**WHEREAS**, it shall be the policy of the State to provide special protection to children in situations of armed conflict from all forms of abuse, violence, neglect, cruelty, discrimination and other conditions prejudicial to their development, taking into consideration their gender, cultural, ethnic and religious background;

WHEREAS, the Office of the Municipal Mayor through its local offices such as, the Office of the Municipal Social Welfare and Development, Philippine National Police - San Benito Municipal Police Station and all other concerned offices are hereby enjoined to implement this Republic Act within the territorial jurisdiction of this Municipality;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by Sangguniang Bayan Member Cindy R. Agati, be it;

RESOLVED AS IT IS HEREBY RESOLVED to adopt REPUBLIC ACT NO. 11188, ENTITLED - AN ACT PROVIDING FOR THE SPECIAL PROTECTION OF CHILDREN IN SITUATIONS OF ARMED CONFLICT AND PROVIDING PENALTIES FOR VIOLATIONS THERETO. OTHERWISE KNOWN AS SPECIAL PROTECTION OF CHILDREN IN SITUATIONS OF ARMED CONFLICT ACT AND ALL ITS PROVISIONS CONTAINING THERETO ARE TO BE IMPLEMENTED AND ENFORCEABLE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of the Municipal Mayor of San Benito, Surigao del Norte, Office of the MSWDO and the PNP - San Benito Municipal Police Station and all concerned offices for information and proper implementation of the above mentioned national law;
