RESOLUTION NO. 001 Series of 2024

“A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND “BONGBONG” R. MARCOS, JR THROUGH HONORABLE ANTONIO ERNESTO F. LAGDAMEO, JR., SPECIAL ASSISTANT TO THE PRESIDENT TO ALLOCATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (₱ 100,000,000.00) TO BE USED FOR THE CONCRETING OF THE 4 KILOMETERS SAN BENITO – NUEVO CAMPO FARM TO MARKET ROAD / LOCAL ACCESS ROAD GOING TO SAN BENITO PORT OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the 4 - Kilometer San Benito – Nuevo Campo Road is considered as Farm–to-Market Road and at the same time a Local Access Road going to San Benito Port;

WHEREAS, the San Benito -Nuevo Campo Road serves as the main road of the people of Barangays Nuevo Campo and Poblacion San Benito in transporting their farm products from their respective barangays going to the poblacion of the Municipality of San Benito, Siargao Island, Surigao del Norte;

WHEREAS, for almost two (2) decades, this road really needs to be concreted for the reason that it is very impassable, muddy and unsafe for the farmers in transporting their farm products to the poblacion of San Benito either by means of barefoot walk and or habal-habal ride and that they were compelled to use another route passing through the Municipalities of San Isidro and Del Carmen respectively;

WHEREAS, due to this prevailing situation the agony of the farmers of San Benito are being aggravated and that this led to their economic losses due to high cost of transportation and long way travel, thus a need of immediate concreting of that road is very vital and of paramount importance;

WHEREAS, the Barangay Nuevo Campo is considered one of the Agrarian Reform Communities (ARC) identified by the Department of Agrarian Reform in this municipality;

WHEREAS, the Municipal Government of San Benito, being a 6th Class LGU and in cognizance of its very limited resources it could not definitely finance its construction, thus financial help and assistance from the highest official of the land, the President of the Republic of the Philippines, His Excellency Ferdinand “Bongbong” R. Marcos, Jr. through Honorable Special Assistant to the President of the Philippines is very vital and of paramount importance;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by Sangguniang Bayan Member William A. Polican, be it,

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request His Excellency Ferdinand “Bongbong” R. Marcos, Jr., President of the Republic of the Philippines through Honorable Antonio Ernesto F. Lagdameo, Jr., Special Assistant to the President to allocate funds as financial assistance in the amount of One Hundred Million Pesos (P 100,000,000.00) for the Concreting of the 4 Kilometers San Benito – Nuevo Campo Farm To Market Road / Local Access Road going to San Benito Port of the Municipality of San Benito, Siargao Island, Surigao del Norte;




