“A RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) IN RELATION TO THE AVAILMENT AND IMPLEMENTATION OF THE BATCH REQUEST QUERY SYSTEM (BREQS) IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Batch Request Query System (BREQS) of the Philippine Statistics Authority is design to streamline and expedite the process of obtaining PSA-issued documents which will authorizes trusted partners, including local government units (LGUs), to receive requests from the public and issue the requested documents to their clientele; by availing this system, the LGU can enhance its service delivery to the constituents and generate additional income for the municipality;

WHEREAS, the BREQS on the other hand aimed to streamline the collection and analysis of statistical data, facilitating more informed decision making and planning for the local government unit, as this project is crucial in aligning the local governance with accuracy and up-to-date information, ultimately contributing to the overall progress and development of the locality;

WHEREAS, the use of this BREQS will enable the LGU-San Benito to benefit from the CRS-ITP by providing a facility where its constituents can secure copies of Civil Registry Records issued by a Serbilis Outlet;

WHEREAS, this BREQS include an application software for encoding details of requests for copy issuances and CRDs in addition, the software has the capabilities for querying and batching the records and generation of reports;


WHEREAS, this computerization and digitalization program is very important and vey necessary to ensure fast track and updated delivery of public services to our constituents which will result to a more effective and efficient local governance;


WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sanggunang Kabataan Federation President Aira Mae C. Galano be it,


RESOLVED AS IT IS HEREBY RESOLVED to grant authority to the Municipal Mayor, Honorable Ma. Gina Sumando-Menil, LCB to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito with the Philippine Statistics Authority (PSA) in relation to the availment and implementation of the Batch Request Query System (BREQS) in the Municipality of San Benito, Siargao Island, Surigao del Norte;


