**“A RESOLUTION DECLARING VALID AND OPERATIVE APPROPRIATION ORDINANCE NO. 01 SERIES OF 2023 OF THE SANGGUNIANG KABATAAN OF BARANGAY STA. CRUZ, SAN BENITO, SURIGAO DEL NORTE, ENACTING ITS 10% ALLOCATION FOR CALENDAR YEAR 2024 IN THE TOTAL AMOUNT OF THREE HUNDRED THIRTY-FOUR THOUSAND FOUR HUNDRED FIFTEEN PESOS AND FIFTY CENTAVOS (P 334,415.50)”**




