GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO (LGU-SAN BENITO) BETWEEN AND AMONG THE DEPARTMENT OF HEALTH - CARAGA CENTER FOR HEALTH DEVELOPMENT (DOH-CHD) HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, DR. CESAR C. CASSION, MD, MPH, CESO III AND DR. ROSE ANN T. ALMOITE, RMT, MD IN RELATION TO THE IMPLEMENTATION OF THE DOCTORS TO THE BARRIOS (DTTB) PROGRAM IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipality of San Benito, Siargao island, Surigao del Norte is one of the recipient municipalities in Caraga Region to avail the Doctors to the Barrios (DTTB) Program of the Department of Health (DOH);

WHEREAS, this DTTB Program of the DOH is a composite program of Human Resource for Health (HRH) Deployment program which aims to deploy physicians in priority areas, especially in hard-to-reach, far-flung, doctorless municipalities for purposes of assisting in the improvement of local public health systems;


WHEREAS, guided by the provisions of the MOA, this tripartite agreement between and among DOH, LGU-San Benito and the DTTB – Rural Health Physician shall be effective and enforceable within three years, starting January 8, 2024 until January 8, 2027, unless revoked, suspended or terminated for reasons stated under Article IV of this MOA;


