“A RESOLUTION INTERPOSING CONFIRMATION AND AFFIRMATION OF THE DEED OF DONATION EXECUTED BY AND BETWEEN THE FORMER MUNICIPAL OFFICIALS OF SAN BENITO (MUNICIPAL MAYOR, MUNICIPAL VICE MAYOR AND SANGGUNIAN BAYAN MEMBERS) BEING THE DONORS AND PSINSP LADY DALIGDIG ARAY BEING THE DONEE, REPRESENTING THE PHILIPPINE NATIONAL POLICE (PNP) IN RELATION TO THE DONATED PORTION OF LOT OWNED BY THE MUNICIPAL GOVERNMENT OF SAN BENITO TO BE USED FOR THE PURPOSE OF ESTABLISHING A PERMANENT SITE FOR PNP MUNICIPAL POLICE STATION OF SAN BENITO, SURIGAO DEL NORTE WITH A TOTAL AREA OF 460 SQUARE METERS”

WHEREAS, the former Municipal Officials of San Benito, Surigao del Norte composed of the Municipal Mayor, Municipal Vice Mayor and the Sangguniang Bayan Members donated a portion of lot owned by LGU-San Benito to the Philippine National Police for purposes of establishing a permanent site of the PNP Municipal Police Station of the Municipality of San Benito, Surigao del Norte through Municipal Resolution No. 031 series of 2015;

WHEREAS, there was a technical discrepancy observed in the documents related to the Deed of Donation having inconsistency in the size of the area contained in the resolution which have an area of 432 square meters as against the size of the area contained in the deed of

donation itself with an area of 460 square meters, creating a technical glitch and obscurity in general;

WHEREAS, this Municipal Council belonging to the 10th Sangguniang Bayan is unanimously interposing confirmation and affirmation of the Deed of Donation executed by and between the Former Municipal Officials of San Benito (Municipal Mayor, Municipal Vice Mayor and Sangguniang Bayan Members) being the Donors and PSINSP Lady Daligdig Aray being the Donee, representing the Philippine National Police (PNP) in relation to the donated portion of lot owned by the Municipal Government of San Benito to be used for the purpose of establishing a permanent site for PNP Municipal Police Station of San Benito, Surigao del Norte with a total area of 460 square meters;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Aldrein C. Glimane, be it:






