**“A RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR, HONORABLE Ma. GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO (LGU-SAN BENITO) BETWEEN AND AMONG THE DEPARTMENT OF AGRICULTURE - BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA-BFAR) HEREIN REPRESENTED BY ITS NATIONAL DIRECTOR, ATTY. DEMOSTHENES R. ESCOTO, BFAR - FISHERIES REGIONAL OFFICE XIII HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, OMNIA B. OLAMA AND SAN BENITO FISHERFOLK COOPERATIVE (SABEFICO) HEREIN REPRESENTED BY ITS PRESIDENT, MR. ROLLY M. TEMPLADO IN RELATION TO THE PROVISION, OPERATION AND MANAGEMENT OF ONE (1) UNIT 62-FOOTER FRP HANDLINE FISHING BOAT, INCLUDING FISHING GEARS AND ACCESSORIES IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the Municipality of San Benito, Siargao island, Surigao del Norte is one of the recipient municipalities in the Philippines to avail the Capacitating Municipal Fisherfolks Program of the Department of Agriculture – Bureau of Fisheries and Aquatic Resources (DA-BFAR);

**WHEREAS**, under this program, the DA-BFAR will provide Purse Seine/Handline/Bagnet Fishing Boats to qualified beneficiaries, in order to improve the capacity of municipal/small-scale fisherfolk to participate in utilizing fish resources in coastal/municipal waters and beyond, thereby improving their efficiency and productivity and their income/socioeconomic status;

**WHEREAS**, the DA-BFAR, as recommended by its Fisheries Regional Office, in coordination with the concerned LGU/s, found the San Benito Fisherfolk Cooperative (SABEFICO), eligible for this DA-BFAR project;

**WHEREAS**, the San Benito Fisherfolk Cooperative (SABEFICO), a group of bona fide municipal/small-scale fishermen/fisherfolk Cooperative, fully equipped with fishing skills and competencies, was chosen by the DA-BFAR through the FishR to take full responsibility for maintaining and managing the Project;

**WHEREFORE**, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member Cindy R. Agati be it:

**RESOLVED AS IT IS HEREBY RESOLVED** to grant authority to the Municipal Mayor, Honorable Ma. Gina Sumando-Menil, LCB to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito (LGU-San Benito) between and among the Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR) herein represented by its National Director, Atty. Demosthenes R. Escoto, BFAR - Fisheries Regional Office XIII herein represented by its Regional Director, Omnia B. Olama and San Benito Fisherfolk Cooperative (SABEFICO) herein represented by its President, Mr. Rolly M. Templado in relation to the provision, operation and management of one (1) Unit 62-Footer FRP Handline Fishing Boat, including Fishing Gears and Accessories in the Municipality of San Benito, Siargao Island, Surigao del Norte;
