FRASCO, SECRETARY OF THE DEPARTMENT OF TOURISM (DOT) TO ALLOCATE FUNDS IN THE AMOUNT OF TWELVE MILLION PESOS (P 12,000,000.00) TO BE USED FOR THE CONSTRUCTION OF TOURIST REST AREA (TRA) OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

WHEREAS, the Tourist Rest Area (TRA) is a flagship project of the Department of Tourism (DOT), considered as a convergence point where foreign and local travelers could approach to access information on tourism sites and attractions, activities, accommodations; reporting concerns related to safety and security; and gaining access to other provisions necessary during their stay at a destination;

WHEREAS, the Municipality of San Benito, however, being one of the 9 municipalities in Siargao Island offers several tourism products such as white beaches, virgin islands and islets, vast hectarage of about 280 hectares fair condition Marine Fish Sanctuary best for scuba diving, fireflies sanctuary for firefly watching, and Poneas Hidden Lake for mountain climbing, nature trekking, kayaking and other several activities:
