“A EARNESTLY REQUESTING TERESITA G. ENCHIONG, Ed.D., DPM, VICE CHAIRPERSON & EXECUTIVE DIRECTOR OF THE EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCD) TO APPROPRIATE FUNDS IN THE AMOUNT OF THREE MILLION PESOS (P 3,000,000.00) AS FINANCIAL ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF SAN BENITO. SIARGAO ISLAND, SURIGAO DEL NORTE FOR THE REPAIR AND REHABILITATION OF THE NATIONAL CHILD DEVELOPMENT CENTER LOCATED AT BRGY. TALISAY, SAN BENITO SEVERELY AFFECTED BY THE ONSLAUGHT OF SUPER TYPHOON ODETTE “

WHEREAS, the Municipality of San Benito, Siargao Island, Surigao del Norte is one of the recipient-LGUs in Caraga Region to avail the construction of National Child Development Center (NCDC) located at Brgy. Talisay, San Benito, Siargao Island, Surigao del Norte last 2020;

WHEREAS, the construction of this building is already finish and is ready to serve its purpose for the benefits and welfare of our learners, however an unforeseen disaster of highest magnitude occurred in Siargao Island on December 16, 2021 which definitely charted the course of history of our island;

WHEREAS, the onslaught of Super Typhoon Odette brought severe damages to the people of this municipality based on the result of the Rapid Damage Needs Assessment (RDNA) conducted by the composite team of MDRRMO, MSWDO, MEO and MAO, which revealed that 100% of the total population were considered Internally Displaced Persons (IDPs) and that all of the six barangays mean of livelihood (fishing & farming) including shelters and infrastructure projects owned by the government and private individuals were greatly devastated and severely damaged;

WHEREAS, the existing NCDC building was not spared from the wrath of this super typhoon, thus brought severe destruction of said government facility, making it not any more fit to serve its purpose of being a pivotal ground for the implementation of ECCD programs and services especially the Early Learning Programs and Family Support Program;


WHEREAS, considering that the municipality is a 6th Class Municipality, it is definitely impossible to finance this rehabilitation project using our local funds, thus, financial assistance from the Early Childhood Care and Development Council (ECCD) through Dr. Teresita G. Enchiong, Vice Chairperson & Executive Director is of paramount importance;



Enchiong, Ed.D., DPM, Vice Chairperson & Executive Director of the Early Childhood Care and Development Council (ECCD) to appropriate funds in the amount of **THREE MILLION PESOS (P 3,000,000.00)** as financial assistance to the Municipal Government of San Benito, Siargao Island, Surigao del Norte for the repair and rehabilitation of the National Child Development Center located at Brgy. Talisay, San Benito severely affected by the onslaught of Super Typhoon Odette;


