"A RESOLUTION EARNESTLY REQUESTING HONORABLE MANUEL "LITO" M. LAPID, SENATOR OF THE REPUBLIC OF THE PHILIPPINES, CHAIRMAN, SENATE COMMITTEE ON GAMES AND AMUSEMENT (19TH CONGRESS) TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P 10,000,000.00) AS ADDITIONAL FUNDING FOR THE CONSTRUCTION OF MULTI-PURPOSE FACILITY IN BARANGAY TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE"

WHEREAS, through the benevolence of Senator Manuel "Lito" M. Lapid, the Municipal Government of San Benito, Siargao Island is a recipient of the Ten Million Pesos (P 10,000,000.00) Construction of Multi-Purpose Facility located at Brgy. Talisay, San Benito, Siargao Island Island, Surigao del Norte;

WHEREAS, the intent and purpose of this Multi-Purpose Facility located at Brgy. Talisay is to be used for accommodation facility of all tourists (both local and foreign) visiting the town of San Benito and all its tourist destinations, given the fact that there is no accommodation facility the Municipality of San Benito has until this present time;

WHEREAS, upon evaluation of the costing of the project, it revealed that the Ten Million Pesos worth of assistance of the good Senator Lito Lapid is not enough to complete the construction of said multi-purpose facility building, thus, the Municipal Officials and the people

of San Benito is earnestly requesting Senator Lito M. Lapid to extend additional Ten Million Pesos (P 10,000,000.00) to complete the construction of said government edifice;

WHEREAS, the Municipal Government of San Benito, Siargao Island being a 6th class LGU precisely has no funds to augment the necessary amount for its completion, thus the additional financial assistance from the Office of Senator Manuel M. Lapid is very vital and of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by SKF President Aira Mae C. Galano, be it:
