RESOLUTION NO. 039 Series of 2024

“A RESOLUTION EARNESTLY REQUESTING HONORABLE AQUILINO “KOKO” L. PIMENTEL, III, SENATOR OF THE REPUBLIC OF THE PHILIPPINES, SENATE MINORITY FLOOR LEADER (19TH CONGRESS) TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (₱ 100,000,000.00) TO FUND THE CONSTRUCTION OF THE 2ND PHASE OF SAN BENITO PORT DEVELOPMENT PROJECT IN BARANGAY TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipality of San Benito, Siargao Island, Surigao del Norte is blessed to be a recipient of the Thirty Million Pesos (₱ 30,000,000.00) infrastructure project entitled, “Construction of San Benito Port Development – Phase I, which was already completed last Fiscal Year 2018 implemented by the Philippine Ports Authority – Port Management Office of Surigao;

WHEREAS, the Phase I of San Benito Port Development construction was purely establishing a concrete causeway at about 70 - meters length and 6 - meters width with back up area connecting the existing causeway of San Benito Port;

WHEREAS, based on the observation by the Municipal Officials and the public in general, said port development project in San Benito is very serviceable and operational, for there were already several barges and ships that were able to dock and unload their carried freight, usually construction materials (sand and gravel) servicing the whole of Siargao Island;

WHEREAS, continuation of Phase 2 construction of Port of San Benito is of paramount importance for it will definitely cater all other shipping vessels that are flying to Siargao Island, an alternative port from that Port of Dapa capable of direct route from Surigao City to Siargao;

WHEREAS, realization of this Phase 2 Project is seen to be a catalyst of economic development of the people of San Benito, being classified as a 6th - class municipality with very limited local income and minimal sources of livelihood;

WHEREAS, the Municipal Government of San Benito, Siargao Island being a 6th class LGU precisely has no funds to augment the necessary amount to start the construction of said additional phase, thus financial assistance from the Office of Senator Koko L. Pimentel, III is very vital and of paramount importance;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member William A. Polican duly seconded by Sangguniang Bayan Member Aldrein C. Glimane, be it:

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Honorable Aquilino "Koko" L. Pimentel, III, Senator of the Republic of the Philippines, Senate Minority Floor Leader (19th Congress) to extend financial assistance in the amount of One Hundred Million Pesos (₱ 100,000,000.00) to fund the Construction of the 2nd Phase San Benito Port Development Project in Barangay Talisay, San Benito, Siargao Island, Surigao del Norte;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of Senator Manuel M. Lapid, GSIS Building, Financial Center, Roxas Boulevard, 1300 Pasay City for information and favorable action;






