BONGDO, SAN BENITO, SURIGAO DEL NORTE IN THE AMOUNT OF TEN MILLION PESOS (₱ 10,000,000.00) UNDER GENERAL APPROPRIATION ACT (GAA) OF 2024 AND FURTHER ENDORSING BARANGAY RESOLUTION NO. 004 SERIES OF 2024 OF BARANGAY BONGDO, SAN BENITO, SURIGAO DEL NORTE FOR PROTECTED AREA MANAGEMENT BOARD (PAMB) APPROVAL”
