“RESOLUTION INTERPOSING NO OBJECTION ON THE CONSTRUCTION OF SLOPE PROTECTION STRUCTURE ALONG JCT. SAN BENITO – STA. MONICA ROAD LOCATED AT BRGY. STA. CRUZ, SAN BENITO, SURIGAO DEL NORTE IN THE AMOUNT OF FORTY MILLION PESOS (P 40,000,000.00) UNDER GENERAL APPROPRIATION ACT (GAA) OF 2024 AND FURTHER ENDORSING BRGY. STA. CRUZ RESOLUTION NO. 007 S. 2024 FOR PROTECTED AREA MANAGEMENT BOARD (PAMB) APPROVAL”

WHEREAS, presented for consideration is the request of the Project Management Team of LGU-San Benito, requesting this august body for the interposition of no objection on the construction of Slope Protection Structure along Jct. San Benito – Sta. Monica Road worth **Forty Million Pesos (P 40,000,000.00) under the General Appropriation Act (GAA) of 2024**, situated at Barangay Sta. Cruz, San Benito, Surigao del Norte and further requesting for the endorsement of Brgy Sta. Cruz Resolution No. 007 series of 2024 for PAMB approval;

WHEREAS, upon careful study of the documents submitted and upon compliance to the documentary requirements, it revealed that the proposed construction of Slope Protection Structure along Jct. San Benito – Sta. Monica Road worth Forty Million Pesos (P 40,000,000.00) under the General Appropriation Act (GAA) of 2024 does not cause any violation to the Zoning regulation set forth by the Municipal Government of San Benito and that this slope protection is beneficial to the well-being of the people of the Municipality of San Benito, Siargao island, Surigao del Norte;




