“RESOLUTION ESTABLISHING A MUNICIPAL SUB-STATION OF THE PHILIPPINE COAST GUARD (PCG) IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE AND FURTHER AUTHORIZES THE USE OF OFFICE SPACE IN RELATION THERETO IN THE EXISTING SAN BENITO COMMERCIAL CENTER BUILDING OR SAN BENITO MUNICIPAL TOURISM BUILDING LOCATED AT THE RECLAMATION AREA, BARANGAY TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the island of Siargao is a maritime corridor where sea vessels and sea crafts of any type is regularly plying over this route, thus a need of a certain Government Agency task to handle and is responsible for maritime safety, security, law enforcement, search and rescue, and maritime environmental protection is of vital importance;

WHEREAS, this august body in its 42nd Regular Session on December 18, 2023 has resolved to pass Municipal Resolution No. 114 series of 2023, granting authority to the Municipal Mayor, Hon. Ma. Gina Sumando-Menil, LCB to establish a Sub-Station of Philippine Coast Guard (PCG) in this municipality;

WHEREAS, along with the establishment of the said PCG Sub-Station, there is a need to identify its location where to conduct its routinary office works as well as the barracks /quarter of its personnel in order to function effectively as true guardians and protectors of the coastal areas /


communities of the Municipality of San Benito, Siargao Island, hence the passage and adoption of this resolution;



RESOLVED AS IT IS HEREBY RESOLVED to establish a Municipal Sub-Station of the Philippine Coast Guard (PCG) in the municipality of San Benito, Siargao Island, Surigao del Norte and further authorizes the use of Office Space in relation thereto in the existing San Benito Commercial Center Building or San Benito Municipal Tourism Building located at the Reclamation Area, Barangay Talisay, San Benito, Siargao Island, Surigao del Norte;


