EMMANUEL S. MENIL AND FURTHER ENDORSING BARANGAY RESOLUTION NO.____ SERIES OF 2024 OF BARANGAY SAN JUAN, SAN BENITO, SURIGAO DEL NORTE FOR PROTECTED AREA MANAGEMENT BOARD (PAMB) APPROVAL”
