GINA SUMANDO - MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN IN BEHALF OF THE MUNICIPALITY OF BENITO, SURIGAO DEL NORTE WITH DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR IN RELATION TO SUPPLEMENTARY FEEDING PROGRAM OF DAY CARE CHILDREN IN THE MUNICIPALITY"

WHEREAS, the Municipality of San Benito, Surigao del Norte is one of the recipient municipalities in the region to avail the Early Childhood Care and Development (ECCD) Program of the Department of Social Welfare and Development (DSWD);

WHEREAS, the "Supplementary Feeding Program" is the provision of food in addition to the regular meals, to currently enrolled day care children as part of DSWD's contribution to the ECCD Program of the government;

cognizance of the beneficial effects of this program to the day care children of San Benito, hence the adoption of this resolution;
