“RESOLUTION EARNESTLY REQUESTING DIR. POL M. DELOS SANTOS, REGIONAL DIRECTOR, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) CARAGA REGION XIII, BUTUAN CITY TO CANCEL AND DELETE THE INSTALLATION / PLACEMENT OF HEXAPODS AND DIVERT IT INSTEAD INTO ADDITIONAL CONSTRUCTION OF LINEAR METERS OF SHORE PROTECTION STRUCTURE (SEAWALL) PROJECT LOCATED AT BRGY. TALISAY, SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE AND ISSUE A CORRESPONDING VARIATION ORDER RELATIVE THERETO”

WHEREAS, the Municipal Government of San Benito (LGU-San Benito) is fortunate to be one of the recipient municipalities in Caraga Region to be granted the infrastructure project, entitled “Construction of Shore Protection in Barangay Talisay, San Benito, Siargao Island, Surigao del Norte worth One Hundred Fifty Million Pesos (₱ 150,000,000.00)” under the General Appropriation Act (GAA) FY 2024;

WHEREAS, in the Program Of Works and Detailed Engineering Design (POW & DED) of this Construction of Shore Protection Structure there is an installation of hexapods component along the seawall;

WHEREAS, the Office of the Municipal Mayor through the recommendation of the Municipal Engineering Office has endorsed to the Office of the Sangguniang Bayan to make

certain modification through resolution, requesting the DPWH Regional Director to modify the POW containing the installation of hexapods by cancelling and deleting it and instead divert it into additional linear meters of shore protection structure and issue corresponding variation order relative to this request;


WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Felix B. Sumando, Sr. duly seconded by Sangguniang Bayan Member William A. Polican, be it;


RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Dir. Pol M. Delos Santos, Regional Director, Department of Public Works and Highways (DPWH) Caraga Region XIII, Butuan City to cancel and delete the installation / placement of Hexapods and divert it instead into additional Construction of Linear Meters of Shore Protection Structure (Seawall) Project located at Brgy. Talisay, San Benito, Siargao Island, Surigao del Norte and issue a corresponding Variation Order relative thereto;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of the DPWH Regional Director, DPWH Caraga Region XIII, Jose Rosales Avenue, Butuan City, 8600 for information and favorable action;


