“A RESOLUTION EARNESTLY REQUESTING GENERAL MANAGER MELQUIADES A. ROBLES OF THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) THROUGH DIRECTOR IMELDA A. PAPIN TO DONATE ONE (1) UNIT PATIENT TRANSPORT VEHICLE (AMBULANCE CAR) WITH COMPLETE MEDICAL ACCESSORIES FOR THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”

WHEREAS, the Municipal Officials of the Municipality of San Benito, Siargao Island, Surigao del Norte learned that the Philippine Charity Sweepstakes Office (PCSO), in its continuing drive of providing services to the far-flung communities in the country is incessantly providing Patient Transport Vehicles (ambulance cars) to those local government units which does not yet bless with this kind of health vehicle;

WHEREAS, such vehicle is so vital and indispensable in the implementation of health programs and activities pipelined by the health officials of this municipality;

WHEREAS, the Municipality of San Benito has only one small rural health center, serving the whole community and most of our patients who could not be any more accommodated by this small health center are advised to be admitted and referred to district hospitals which have the proximity of two or three municipalities away from the poblacion of San Benito, thus services of an ambulance car is of paramount importance and very inevitable;

WHEREAS, the Municipal Government of San Benito (LGU-San Benito) and the Philippine Charity Sweepstakes Office (PCSO) has a signed and agreed through a MOA for the

establishment and operation of PCSO Lotto and PCSO Small Town Lottery (STL) in the Municipality of San Benito which subsequently allows the LGU-San Benito to receive its equitable share from the charity funds of PCSO;


WHEREAS, considering the Municipality of San Benito is a 6th class LGU, it is definitely improbable to acquire this kind of vehicle using the very limited resources of the municipality, thus intercession of the Philippine Charity Sweepstakes Office (PCSO) is of vital importance;


