**“A RESOLUTION EARNESTLY REQUESTING GENERAL MANAGER MELQUIADES A. ROBLES OF THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) THROUGH DIRECTOR IMELDA A. PAPIN TO ALLOCATE FUNDS IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P 100,000.00) AS FINANCIAL ASSISTANCE TO BE USED FOR THE PROCUREMENT OF ASSORTED MEDICINES FOR THE RURAL HEALTH UNIT OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE”**

**WHEREAS**, the Municipal Officials of the Municipality of San Benito, Siargao Island, Surigao del Norte learned that the Philippine Charity Sweepstakes Office (PCSO) aside from providing PTVs and medical assistance to LGUs, PCSO is also providing financial assistance for the procurement of assorted medicines to those indigent individuals who cannot afford to provide its own medicines, especially those in the far-flung areas in the country;

**WHEREAS**, such assorted medicines is so paramount and indispensable to the sustainability of medical care of the people of San Benito, especially those who have taken their maintenance medications and those in times of emergency situations;

**WHEREAS**, this financial assistance for the purchase of medicines is big enough to cover the budget gap incurred by LGU-San Benito in providing availability of medicines in the rural health unit;

**WHEREAS**, the Municipal Government of San Benito (LGU-San Benito) and the Philippine Charity Sweepstakes Office (PCSO) has a signed and agreed through a MOA for the

establishment and operation of PCSO Lotto and PCSO Small Town Lottery (STL) in the Municipality of San Benito which subsequently allows the LGU-San Benito to receive its equitable share from the charity funds of PCSO;

**WHEREFORE**, for and in consideration of the foregoing premises and through the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Aldrein C. Glimane, be it;

**RESOLVED AS IT IS HEREBY RESOLVED** to earnestly request General Manager Melquiades A. Robles of the Philippine Charity Sweepstakes Office (PCSO) through Director Imelda A. Papin to allocate funds in the amount of One Hundred Thousand Pesos (P 100,000.00) as financial assistance to be used for the procurement of assorted medicines for the Rural Health Unit of the Municipality of San Benito, Siargao Island, Surigao del Norte;


