“A RESOLUTION EARNESTLY REQUESTING HONORABLE FRANCISCO T. LAUREL, JR., SECRETARY OF THE DEPARTMENT OF AGRICULTURE (DA) THROUGH UNDERSECRETARY ALLAN Q. UMALI, USEC FOR ADMINISTRATION FOR THE AVAILMENT OF THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) IMPLEMENTED BY THE DEPARTMENT OF AGRICULTURE AND WORLD BANK AND SUBSEQUENTLY MANIFEST ITS INTENTION OF AVAILING SUCH PROGRAM BY THE MUNICIPAL GOVERNMENT OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE (LGU-SAN BENITO) THROUGH THE LETTER OF INTENT TO BE EXECUTED BY THE LOCAL CHIEF EXECUTIVE, HONORABLE MA. GINA SUMANDO-MENIL, LCB RELATIVE TO THIS PURPOSE”

WHEREAS, the National Government through the Department of Agriculture (DA) and the World Bank are implementing the Philippine Rural Development Project (PRDP) that are readily available to all LGUs in the country especially those belonging to 5th and 6th class municipalities;

WHEREAS, the Philippine Rural Development Project (PRDP) is a six-year national project under the Department of Agriculture (DA) that aims to establish a modern, value chain-oriented and climate-resilient agriculture and fisheries sector; likewise, it aims to strengthen good governance, transparency and accountability mechanisms at all stages of the project cycle. It also intends to operationalize a local-level convergence platform among relevant national line agencies and other stakeholders such as the private sector, civil society and academe to synergize

programs and projects. This multi-stakeholder convergence is seen to facilitate the implementation of more relevant interventions that benefit a bigger segment of farmers and fishers, ushering them towards inclusive growth;

WHEREAS, the PRDP is seen to be the appropriate approach to development particularly in the Municipality of San Benito, Siargao Island, Surigao del Norte considering that the chief income sources of the people of San Benito heavily anchored on farming and fishing;

WHEREAS, there is really an urgent and pressing need for agricultural modernization and upgrading for our marginalize fishermen and farmers to finally alleviate their present economic condition, thus through PRDP with all its infrastructure and economic enterprise development interventions, the dream of the people of San Benito for economic freedom is definitely at hand;

WHEREAS, the Municipal Government of San Benito, being a 6th Class LGU is definitely having no capacity to finance agricultural infrastructure development projects, thus interventions from outside sources is very vital & of paramount importance, hence the adoption of this resolution;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded SKF President Aira Mae C. Galano, be it,

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Honorable Francisco T. Laurel, Jr., Secretary of the Department of Agriculture (DA) through Undersecretary Allan Q. Umali, Usec for Administration for the availment of the Philippine Rural Development Project (PRDP) implemented by the Department of Agriculture and World Bank and subsequently manifest its intention of availing such program by the Municipal Government of San Benito, Siargao Island, Surigao del Norte (LGU-San Benito) through the Letter of Intent to be executed by the Local Chief Executive, Honorable Ma. Gina Sumando-Menil, LCB relative to this purpose;


