### **RESOLUTION NO. 068**

"A RESOLUTION EARNESTLY HONORABLE GRACE L. POE, SENATOR OF THE REPUBLIC OF THE PHILIPPINES (19<sup>TH</sup> CONGRESS), CHAIRMAN, SENATE COMMITTEE ON PUBLIC INFORMATION AND MASS MEDIA TO APPROPRIATE FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY MILLION PESOS (\$\text{P}\$ 30,000,000.00) TO BE USED FOR THE CONCRETING OF BARANGAY ROADS WITH SOLAR LIGHT OF THE THREE (3) COMPONENT BARANGAYS OF THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE, NAMELY: BARANGAYS BONGDO, MARIBOJOC AND NUEVO CAMPO RESPECTIVELY"

WHEREAS, majority of the existing barangay roads in the different barangays of San Benito for the longest time remains in its earthen state and were never cemented thereby, causing discomfort among road users, pedestrians and motor vehicles especially during heavy downpour and bad weather condition;

WHEREAS, this deplorable condition of the barangay roads of San Benito exacerbated the prolonged agony of the people especially those living in the far-flung areas which definitely impacted their current living condition;

WHEREAS, concreting of these barangay roads definitely bring economic return to the people of Brgys. Bongdo, Maribojoc and Nuevo Campo, for this will provide easy access of bringing their farm and fishery products down to nearby public market;

WHEREAS, the Municipality of San Benito, being a 6<sup>th</sup>- class LGU definitely could not finance construction of such project using only its limited resources, thus financial intervention and help from the good Office of Senator Grace L. Poe is in dire need and of paramount importance:

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Aldrein C. Glimane duly seconded LNMB President Ruella T. Rulete, be it,

RESOLVED AS IT IS HEREBY RESOLVED to earnestly request Honorable Grace L. Poe, Senator of the Republic of the Philippines (19th Congress), Chairman, Senate Committee on Public Information and Mass Media to appropriate funds as financial assistance in the total amount of Thirty Million Pesos (P 30,000,000.00) for the Concreting of Barangay Roads with Solar Light of the three (3) component barangays of the Municipality of San Benito, Siargao Island, Surigao del Norte, where such funds were being proportionately divided equally with the following breakdown:
