“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE MA. GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO (LGU-SAN BENITO) BY AND BETWEEN THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT CARAGA (DOH-CHD Caraga) REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR, CESAR C. CASSION, MD, MPH IN RELATION TO THE IMPLEMENTATION OF HEALTH FACILITY ENHANCEMENT PROGRAM (HFEP – FY 2024) UNDER GENERAL APPROPRIATION ACT OF 2024”

WHEREAS, the Municipality of San Benito is one of the recipient LGUs in Caraga Region to avail the Construction of a Super Health Center Project under the Health Facility Enhancement Program (HFEP) of the Department Of Health (DOH), wherein such construction works is currently on-going;

WHEREAS, the funds for San Benito Super Health Center are a little bit insufficient due to fluctuation of prices of construction materials caused by inflation, thus a need of additional funding support is necessary to finally complete the said project;

WHEREAS, luckily the Department of Health has appropriated this year a total amount of Six Million Pesos (P 6,000,000.00) intended for the completion/upgrading/repair/renovation of the Super Health Center and for the repair of the Rural Health Unit of the Municipality of San Benito, Siargao Island, Surigao del Norte under the under the Health Facility Enhancement Program (HFEP) for Fiscal Year 2024 as approved in the General Appropriation Act of 2024;

WHEREAS, authorization from this august body for the Municipal Mayor to enter into a MOA and sign in behalf of LGU-San Benito by and between DOH is of paramount importance for the implementation of this program;

WHEREFORE, for and in consideration of the foregoing premises and upon the motion of Sangguniang Bayan Member Charlito E. Mendavia duly seconded by Sangguniang Bayan Member Felix B. Sumando, Sr., be it,

RESOLVED AS IT IS HEREBY RESOLVED to authorize the Municipal Mayor, Honorable Ma. Gina Sumando - Menil, LCB to enter into a Memorandum Of Agreement (MOA) and sign in behalf of the Municipal Government of San Benito (LGU-San Benito) by and between the Department Of Health – Center For Health Development Caraga (DOH-CHD Caraga) represented herein by its Regional Director, Cesar C. Cassion, MD, MPH in relation to the implementation of Health Facility Enhancement Program (HFEP – FY 2024) under General Appropriation Act of 2024;

RESOLVED FINALLY, that copy of this resolution be furnished the Office of DOH-CHD Caraga Regional Director, Butuan City and the Office of the Municipal Mayor of San Benito, Surigao del Norte for information and favorable action;


