RESOLUTION NO. 081 Series of 2024

“A RESOLUTION DECLARING VALID AND OPERATIVE BARANGAY ORDINANCE NO. 001 SERIES OF 2024 OF BARANGAY MARIBOJOC, SAN BENITO, SURIGAO DEL NORTE ENTITLED, AN ORDINANCE REVISING BARANGAY TAX ORDINANCE ON LVYING FEES AND CHARGES AS PROVIDED FOR IN ARTICLE IV, SECTION 152, PARAGRAPH (B) OF R.A. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, AMENDING BRGY. TAX ORDINANCE NO. 001 SERIES OF 1994 OF BARANGAY MARIBOJOC, SAN BENITO, SURIGAO DEL NORTE “

WHEREAS, the Barangay Council of Barangay Maribojoc, this Municipality has enacted a tax revenue measure and subsequently submitted to this honorable body for further study and review;

WHEREAS, a tax revenue ordinance serves as an instrument that shall govern the levy, assessment, and collection of taxes, fees, charges and other imposition within the territorial jurisdiction of the LGU;

WHEREAS, its passage is in pursuance of the provision of Section 129 of RA 7160, authorizing LGU to exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy;

WHEREFORE, foregoing premises considered and upon the motion of Sangguniang Bayan Member Delfin P. Labola duly seconded by Sangguniang Bayan Member William A. Polican, be it;

RESOLVED AS IT IS HEREBY RESOLVED to declare valid and operative Barangay Ordinance No. 001 series of 2024 of Barangay Maribojoc, San Benito, Surigao del Norte entitled, An Ordinance Revising Barangay Tax Ordinance on Levying Fees and Charges as provided for in Article IV, Section 152, Paragraph (B) of R.A. 7160, otherwise known as the Local Government Code of 1991, Amending Brgy. Tax Ordinance No. 001 Series of 1994 of Barangay Maribojoc, San Benito, Surigao del Norte;

RESOLVED FINALLY, that copies of this resolution be furnished to the Office of the Punong Barangay of Maribojoc, San Benito, Surigao del Norte, Office of the Municipal Mayor and Office of the Municipal Treasurer for information and guidance;






