GINA SUMANDO-MENIL, LCB TO ENTER INTO A MEMORANDUM OF AGREEMENT AND SIGN IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SAN BENITO (LGU-SAN BENITO) WITH THE SENTRO PARA SA IKAUNLAD NG KATUTUBONG AGHAM AT TEKNOLOHIYA, INC. (SIKAT, INC) REPRESENTED HEREIN BY ITS EXECUTIVE DIRECTOR, MR. ALFREDO L. BERNARTE, JR IN RELATION TO THE IMPLEMENTATION OF PROJECT ENTITLED: STRENGTHENING THE RESILIENCE OF VULNERABLE COASTAL COMMUNITIES IN THE PHILIPPINES TO THE IMPACTS OF CLIMATE CHANGE IN THE MUNICIPALITY OF SAN BENITO, SIARGAO ISLAND, SURIGAO DEL NORTE“

WHEREAS, the Sentro para sa Ikaunlad ng Katutubong Agham at Teknolohiya, Inc. (SIKAT, Inc) is a non-governmental organization that advocates for DRRM-CCA, Community-Based Coastal Resource Management (CBCRM), and the Safeguarding of Children's Rights in the Fisheries Sector, policy reforms, and community development at the national and local levels;

WHEREAS, SIKAT aims to provide support to the LGU of San Benito in mainstreaming climate change adaptation in plan development, strengthening community adaptive capacity and management capacities through ecosystem-based and rights-based approaches and establishing networks or support institutions;


WHEREAS, the project “STRENGTHENING THE RESILIENCE OF VULNERABLE COASTAL COMMUNITIES IN THE PHILIPPINES TO THE IMPACTS OF CLIMATE CHANGE” intends to improve the capacities of local leaders (champions) in the areas of climate adaptation and disaster risk reduction, in enhancing municipal climate adaptation and resource utilization plans that are created and implemented in a participatory manner; and that it also aims to strengthen community-based self-help structures to effectively claim their rights to political participation and in the development of alternative sources of income;






